FROM THE EAST:

Brothers Trevor Pletcher (Secretary), Mike Perdue (Senior Warden), and I attended the Grand Lodge Annual Communication on 5/16/2023. Part of the ceremony was to discuss and vote on the 2023 resolutions as submitted to the Grand Lodge:

Res. 02-23 Minutes. If adopted, the minutes of the Lodge could be emailed or distributed electronically. **Res. 03-23 Proficiency.** If adopted, a newly raised Master Mason would be prohibited from petitioning any masonic appendant or concordant body for 90 days.

Res. 04-23 Notice of Dues. If adopted, the late fee maximum of \$5.00 will be removed from Reg. 37.110 which conflicts with Reg. 37.070 allowing a Lodge to set a late fee higher than \$5.00.

Res. 05-23 Amendments to Res. 09-21. If adopted, the specified language will be added to the resolution prior to consideration of the entire resolution.

Res. 06-23 Limitations on Use of Lodge Room. If adopted, a Lodge having rental space could rent to restaurant serving beer and wine, a two-way liquor license.

Res. 07-23 Who May Not Petition. If adopted, the last sentence is removed giving the Grand Master the ability to heal a person who may have received the degrees in an unrecognized or clandestine Lodge and cause him to take the degrees again without issuing a demit.

Res. 08-23 Consume Alcohol in Lodge Building. If adopted, alcohol can be stored and consumed in the Lodge building.

Also, the Grand Master's recommendations were discussed and voted on:

01-23 Restoration Lodge UD. If adopted, Restoration Lodge UD trial program would be added the Blue Book of Masonic Law.

02-23 Disciplinary Review Committee. If adopted, would add a new committee to review disciplinary matter presented to the Grand Master.

03-23 Alternate Cast for Dedications/Rededications. If adopted, would allow for a different dedication/rededication ceremony using less officers.

The voting outcomes can be discussed in the June Stated Meeting should you have any questions.

From Generation to Generation

IN THE MASONIC WORLD, the office of Grand Master is usually in the hands of an older man, one who has toiled in the quarries for decades. But not always,

Most Worshipful Brad Billings, at age thirty-eight, is the youngest Past Grand Master in the United States, and probably in the world. In 2022, he led 90,000 Freemasons and more than 900 lodges in the Grand Lodge of Texas, the third largest Masonic jurisdiction in America, behind Pennsylvania and Ohio.

Established in 1835, the Grand Lodge of Texas is the oldest continuously operating organization in the Lone Star State. Its members have included governors, senators, judges; and historic figures such as Sam Houston, Davy Crockett, Audie Murphy, and Buzz Aldrin.

"For me, Masonry has been a life-enhancing experience," Most Worshipful Brother Billings said. "The greatest thing is that it has allowed me to find opportunities for servant leadership." He is a graduate of Texas Tech University and works in the pharmaceutical industry.
